The auction will be subjected to the following conditions.

1. The auction will be conducted by the undersigned personally or his authorized nominee at the specified place and time of auction. Every bidder is required to deposit a sum of Rs.1000/- as earnest money before he/she permitted to bid.
2. The Earnest Money is refundable to the unsuccessful bidder at the close of the auction against an acknowledgement.
3. The highest bidder who, herein after called the contractor should on the spot deposit the full amount on the close of auction, failing which the canteen will be re-auctioned at a later convenient date. The highest bidder, besides forfeiting the earnest money, will not hold this office responsible for any loss or gain.
4. The highest bidder should obtain a temporary receipt for the amount deposited from the office in charge who conducted the auction and the same should be exchanged for an authorized receipt to be issued from this office on acceptance of the bid.
5. The highest bidder will keep the Canteen neat and clean.

6. The highest bidder should install the First Aid Kit & Fire Extinguisher in the Canteen as per the requirement of Fire Brigade Services.
8. The highest bidder will engage staff over the age of 18 years in accordance with labor law.
9. All persons engaged by the highest bidder shall be his/ her own employees and they will claim no privileges from ASI. The bidder will be directly responsible for the administration of his employees as regards general discipline and courteous behavior.
