EXPRESSION OF INTEREST

The Superintending Archaeologist, Archaeological Survey of India, Guwahati Circle, Guwahati on behalf of the President of India invites sealed EOI from eligible Architects/Consortium of allied professionals to accomplish 'Documentation of monument : Menhirs & Caves at Vangchhia, Dist. Champai Mizoram'. The monument is under the protection of ASI. The expected scope of work shall include the following tasks besides all other standard components accepted internationally.

1. Detail Drawings of the site and its remains.
2. Condition overlay and appraisal of the site and its remains.
3. Structure and material documentation.
4. Documentation of conservation work done till date.
5. Linking with Archaeological excavations and available evidences.
6. Historical linkage to the design and landscape of the monuments.
7. Assess significance in order to derive value of the site.
8. Assess the factors effecting the values of the site and its condition.
9. Analyse issues effecting the values and its condition from the Archaeological point of view.
10. Estimate for proposed conservation and developmental works of the site.
11. Recommendations.
12. To align the conservation and developmental works within the framework of the AMASAR Act 1958 and AMASAR (Amendment and Validation) Act 2010 towards preparation of conservation and developmental master plan.
13. The works should be completed under the guidance of the Superintending Archaeologist to the full satisfaction of the office.

Time Frame: 1 Month from the date of signing of the agreement, which is within 5 days of award of the work.


Eligibility criteria:
