**Subject: Implementation of Government's decision on the recommendations of the 7th CPC –
Revision of Pension of Pre-2016 Pensioners/family pensioners etc. in ASI – regarding**

Sir/Madam,

On the above mentioned subject-matter, I am directed to refer to DoP&PW's OMs dated 12.5.2017, 6.7.2017 and 25.7.2017 emphasizing early revision of Pre-2016 Pensioners/Family Pensioners etc.

2. Consequently, all the pre-2016 pension cases in ASI are *suo moto* required to be processed/revised by the concerned Head of Offices/DDOs by submitting the cases to the PAOs concerned for completing the process of pension revision, in accordance with the instructions contained in DoP&PW's OM No.38/37/2016-P&PW(A) dated 12th May, 2017 (copy enclosed) with a view that any delay in issuance of revised PPOs of the pre-2016 retirees do not occur. For such revision of pensions, HOOs/DDOs should not ask for any additional information from the retirees/family pensioners in the forms of application/request for revision of pension and other information/documents which include PPO, DoB proof, date of retirement, Bank details etc. A copy of the Concordance Table for pensioners who retired in Group-D pay scales is enclosed for information. All the Concordance Tables may be accessed at http://doppw.gov.in/sites/default/files/38372016-PPWA_060720171.pdf for the purpose of revision of pre-2016 pension cases.

3. With the above objective, all the Offices/HOOs under DG, ASI are directed to take suitable necessary action for revision of all pre-2016 Pension cases on war footing so that the decision of the Government for passing the benefits of the recommendations of the 7th CPC vis-à-vis pensioners / family pensions is successfully and effectively implemented in time.

4. All the HOOs are directed to also furnish the status of revision of pre-2016 Pension cases in the Proforma enclosed herewith latest by 8th September, 2017 for forwarding the same to MoC/DoP&PW. HOOs will be held personally responsible for any delay in this regard and suitable action will be taken against the defaulting officers.
