Road, Patna on all working days upto **5.00 PM from 28.07.2017 to 14.08.2017** against cash payment of Rs.500/- each (non refundable). The date of D/D should be after publication of tender.
4. The cost of tender form (if downloaded from website) in the form of Demand Draft in favour of S.A., A.S.I., Patna Circle, Patna should be enclosed alongwith the tender form which should reach to this office within the stipulated period.
5. The supplier have to produce the Registration Certificate, PAN No., experience certificate of at least 2 years of supplier, Sale Tax Clearance Certificate, TIN Certificate & Character Certificate for obtaining the tender paper.
