

The financial up-gradation under the MACP Scheme shall be purely personal to the officer and shall have no relevance to his seniority position. However, financial and certain other benefits which are linked to the pay drawn by the officer such as HBA, allotment of Government accommodation shall be permitted. As such, there shall be no additional financial up-gradation for the senior officer on the ground that the junior officers in the grade have got higher pay/grade pay under the MACP Scheme.

On up-gradation, the pay of the officers shall be fixed under the provisions of F.R. 22(1)(a(1) read with Department of Expenditure's O.M. No.1/1/2008-IC dated 13.09.2008. The pay fixation benefit allowed under the Scheme shall be final and no fixation benefit shall accrue at the time of regular promotion except the grade pay eligible to the promotion post.

This is subject of Audit and in the event of any excess payment, etc., the excess amount will be recovered.
