CORRIGENDUM


Subject: - Delegation of Financial Powers to Officers of Archaeological Survey of India (ASI) – reg.

Consequent to operationalization of Revised/ New ASI budget subheads as per Rule 8 of DFPR, 1978 with effect from 01.04.2023 in current F.Y. 2023-24 pursuant to issue of O/o the Controller General of Accounts, New Delhi O.M. dated 15.12.2022 (available for download in open domain), the delegation of financial powers to Officers of Archaeological Survey of India to incur Contingent Expenditure as delegated at Para 1(C) of ASI Office Order No. F.23-55/2014-Admn.I (B&A) dated 26 May 2022 (and Corrigendum dated 13.12.2022) for procuring Office Equipment, Furniture & Fixtures, Machinery and Equipment and Information, Computer & Telecommunications (ICT) Equipment, Library Books exceeding the threshold limit of Rs 1.00 Lakhs or three years of useful life, either of two, is no longer valid now as these items are mandatorily required to be procured/ incurred from Capital Expenditure (Assets) Object Class-VI-Non functional Assets (Fixed and Intangible Assets) Object Heads henceforth.

2. With a view to ensure unhindered execution of work by Field Offices of ASI as also timely utilization of already allocated budget, the undersigned is hereby directed to convey that existing financial powers delegated to field officers of ASI (i.e. RDs/ SAs/ Directors etc.) at Para 1(C) of ASI Office Order No. F.23-55/2014-Admn.I (B&A) dated 26 May 2022 (and Corrigendum dated 13.12.2022) to incur Contingent Expenditure (as per Schedule V of DFPR and Table and Annexure) may be exercised for procurement of items in the following ASI Capital budget sub heads during current F.Y. 2023-24 or till such time the revised order for delegation of financial powers is issued by this office: -

- a) HoA 4202.04.107.03.01.52 Machinery & Equipment.
- b) HoA 4202.04.107.03.01.71 Information, Computer, Telecommunications (ICT) Equipment.
- c) HoA 4202.04.107.03.01.74 Furniture & Fixtures.
- d) HoA 4202.04.107.03.01.77 Other Fixed Assets.
